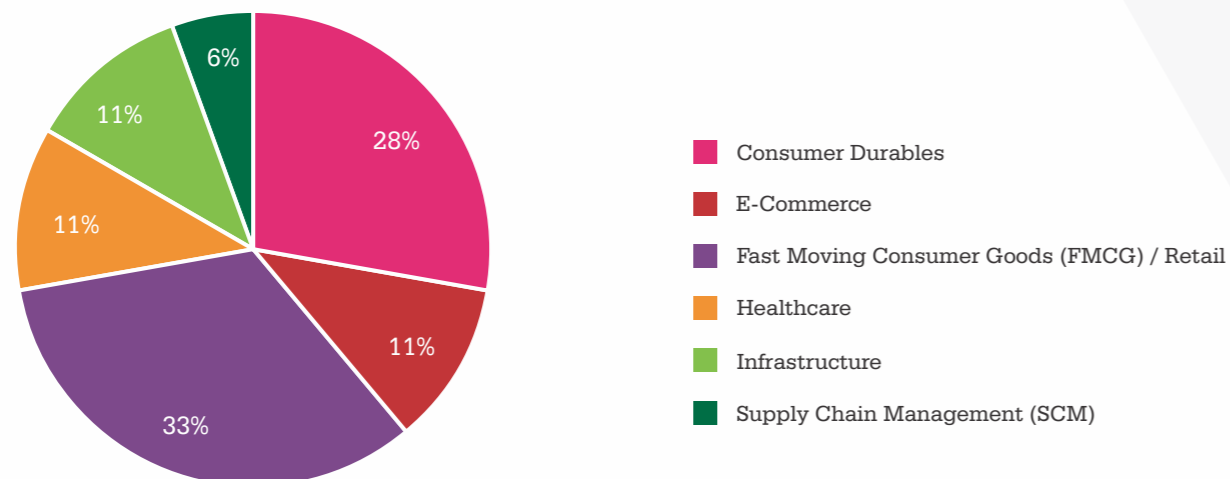

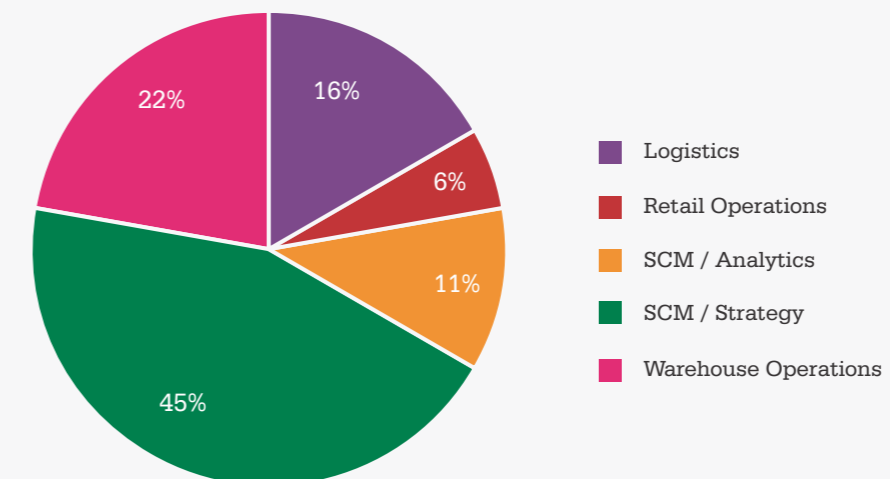
► Sector wise Break up


