- The Institute adheres strictly to the Government of India's reservation policy, reserving 7.5% seats for the ST category and 15% seats for the SC category in admissions to higher education institutions.

- The required CAT percentile for SC and ST candidates is kept at minimal levels to ensure a greater number of candidates from these categories are shortlisted for the Written Analysis Test (WAT) and Personal Interview (PI) process.
- Additionally, setting lower cut-offs for SC and ST candidates not only facilitates their participation in the selection process but also increases the likelihood of their receiving final admission offers.

These initiatives have led to a significant increase in the participation of SC category students in the programs. However, filling the seats reserved for ST candidates remains a challenge.
